Course Overview, Objectives and Timeline:

Social 30-1 and 30-2 are complementary courses. Much of the content is similar, with Social 30-1 going into greater depth and covering a small amount of content not necessary in Social 30-2. Therefore, the courses will be taught as one, with assessments geared specifically for the different courses.

Students will explore the origins and complexities of ideologies and examine multiple perspectives regarding the principles of classical and modern liberalism. An analysis of various political and economic systems will allow students to assess the viability of the principles of liberalism.

Education in Alberta aims to honour cultural diversity and promote intercultural understanding. Students are able to build on foundational knowledge about First Nations, Metis and Inuit peoples. The program of studies provides opportunities for students to develop a knowledge and understanding of, and respect for, the histories, cultures, languages, contributions, perspectives, experiences and contemporary contexts of First Nations, Metis and Inuit.

Unit 1 – *To what extent should ideology be the foundation of identity? (September)*

Students will explore the relationship between identity and ideology.

Unit 2 – *To what extent is resistance to liberalism justified? (October-November)*

Students will assess impacts of, and reactions to, principles of liberalism.

Unit 3 – *To what extent are the principles of liberalism viable? (November-December)*

Students will assess the extent to which the principles of liberalism are viable in a contemporary world.

Unit 4 – *To what extent should my actions as a citizen be shaped by an ideology? (January)*

Students will assess their rights, roles, and responsibilities as citizens.

Current Events: An examination of current affairs, issues and local concerns will occur on an ongoing basis as an integrated component of the Social Studies 20-1 course.

Student Expectations:

The purpose of **reassessment** is to allow a student to remove an uncharacteristic grade. Providing a reassessment is the sole discretion of the teacher. Individual reassessments will only be granted in extenuating circumstances.

Students must be on time for class. They are expected to be in class at the bell. Students that miss 25% of the class will be marked absent. (10 min for 40 min class, 20 min for 80 min class)



Grading Procedures:

Assessment for Learning Policy:

Many in class assignments will be used to assess student progress in class. These are low stakes and intended to provide constructive feedback. Many of these assessments will include written constructive comments for improvement from the teacher. It is expected that students complete all of these assignments.

Assessment of Learning Policy:

Quizzes, exams and in-class essays are all types of assessments that will be used in calculating a final grade for each student. All grades in the course are cumulative. Assessments in each category below will be averaged throughout the year.

Grade Determination:

Term grade determination: Grade will be based upon evaluations conducted throughout the course. This portion of the grade will reflect the student's most consistent level of achievement throughout the course.

Final grade determination:

Grade will be based on the accumulation of term grade evidence and a final examination administered at the end of the course (where applicable; this exam will be based on an evaluation of all units of the course). This grade will reflect the student's most consistent level of achievement throughout the course.

Appeals Process

Should a situation arise where a student is not satisfied with an assessment outcome, first discuss the matter with the teacher outside of class time. If the teacher and the student are unable to resolve the issue, then the teacher will approach another teacher to assess the assignment. (The teacher will not have prior knowledge of the student's name or the previous grade for the given assignment). If there is still an issue, a meeting will be set up between the student, teacher, parents, and administration to resolve the matter. The commencement of an appeal must occur in a timely manner; within 48 hours of receiving the marked assignment. In return, the appeal process will be completed as soon as possible.
